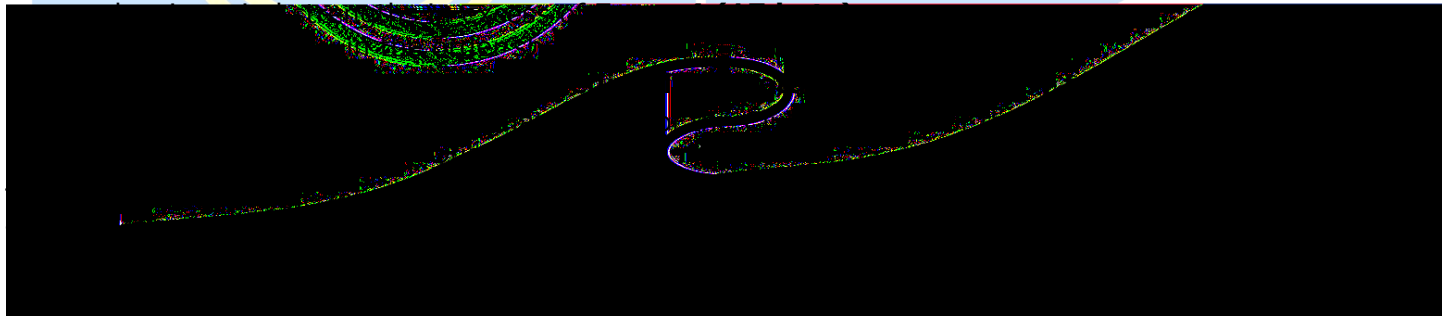

Rules for Dinghy Hire

The Hirer Must:

- be qualified to Stage 3 RYA Youth Sailing Scheme or Level 2 National Sailing Scheme or equivalent skill level for a single handed boat and Stage 4 (YSS) or Level 3 (NSS) or equivalent skill level for two handed boats, unless the user is participating in club training with a coach.
- provide the loan fee and the deposit before being given access to the dinghy.

- be aware of the local conditions and weather. Boats should not be taken out if Cambermet is
